

Official Contest Rules

1. Each entrant may complete only one entry per person or entity. Employees, officers, directors, agents, representatives, and immediate family and household members of www.KSLR.com and/or www.THEANSWER.com and/or THEFISHSANANTONIO.COM and/or www.luzsanantonio.com (“Radio Station”), its parent company, its parent’s affiliated companies, and its advertising and promotion agencies are not eligible to participate in the Contest.
